 - Quotes must be submitted **electronically via email** to CBM Office located in 13 Okemesi Crescent, off Twon brass Street Garki 2, Abuja.
 - The quotation should be on company letterhead duly signed and stamped by an authorized person of the company (or appropriate Proforma Invoice signed and stamped by authorized persons).
